1. Article(s) / Research Paper(s) must be written in either of the five language(s) only i.e.
(a) Hindi (b) English (c) Sanskrit (d) Punjabi (e) Telugu only.
2. Ensure to Type your Research Paper(s) / Article(s) in MS WORD only
3. For HINDI & Sanskrit Paper(s) Use **Kruti Dev 021** strictly with Font size -14
4. For English Paper(s) Use **Times New Roman** strictly with Font size -14
5. For Telugu Paper(s) Use **Anu** strictly with Font Size -14
6. For Punjabi Paper(s) Use **Satluj.ttf** with Font Size - 14
7. Acceptance Letter for Publication shall be issued by the Editor, Tejasvi Astitva Research Journal, strictly after receipt of the concurrence from our Editorial Board on recommendation of the Peer Review Board.
8. Approval to the said Research Paper(s) / Article(s) shall be communicated to the Writer / Author, Co-Author, as the case may be, on their email within 10 days from the date of receipt of the article(s) / Research Paper(s) duly completed with all requisite formality(ies).
9. **The Research Paper(s) / Article(s) submitted shall be strictly published upon receiving due approval from our Editorial Board** duly forwarded through the **Peer Review Board**.
10. Writer / Author must ensure that the article(s) / Research Paper(s) being forwarded and submitted for printing & publishing in Tejasvi Astitva Research Journal is originally the author's / Writer's own creation / production / research work and has neither been copied not taken from the Internet and or is not a repeat article or and has not been published or printed in any other Research Journal / Magazine or any other print media registered under the Press Registration of Book Act (The PRB ACT) / Registrar of Newspapers of India (The RNI) / International Standardization Serial Number (The ISSN) or any other Body of the Govt. of India, which makes the registration of Research Journal(s) mandatory under the Rules / law of the Land (India) in any manner whatsoever. The Editor, Publisher and Management shall not be, in any manner, responsible for a Research Paper(s) / Article(s) being **Rejected** or **Approved**, if any, by our **Editorial Board** and or for any legal consequences arising out of concealing / hiding the facts / truth by the Author / writer, which were or are relevant for disclosure while submitting the article(s) / Research Paper(s) with the Editor Tejasvi Astitva Research Journal, irrespective of the same Paper(s) / Article(s) already **Rejected** or **Approved**, if any, for **Publication** by National/International university/College/ Institution / other Publisher(s), if any, in the past. Hence, it is specifically clarified that Research Paper(s) / Article(s) shall be **accorded Approval** by our **Peer Review Board** and finally by our **Editorial Board at its' Sole discretion in consultation with the Advisory Board and the management of Tejasvi Astitva Research Journal. The final decision shall be of the Editor-in-Chief and the Publisher of Tejasvi Astitva and the Editor shall accord approval to the submitted article / research paper only after the final decision and approval accorded by the Editor-in-Chief & Publisher, Tejasvi Astitva.**

In case of Research papers the author / writer is required to submit a consent, approval and concurrence from the Guide or the person under whose guidance the research paper has been created / written and the Head of the Department / Institution, or otherwise must be referred from any two Subject Experts of higher stature, in order to avoid conflict, if any.
 - iii. Article(s) / Research Paper(s) must be accompanied with Membership form duly completed in all manner (for new members only) and for existing members only membership number may kindly be intimated in the Copyright form
 - iv. Article(s) / Research Paper(s) must be accompanied complete with details of Author(s) / Co-Author(s) / Writer(s) containing full name, Parentage, Complete Permanent and Correspondence address, designation, Land Line & Mobile Cell no(s) and email ID.
 - v. A self-attested Photocopy(ies) of ID Proof, Address Proof & Aadhaar Card must be uploaded and thereafter attached in hard copy with the article(s) / Research Paper(s).
 - vi. An Undertaking / Self – Declaration stating that said Article(s) / Research Paper(s) has / have not been published in any other publication / Print Media / Website(s)/ Blog(s)/ News Channel(s) in the form and shape of complete Article(s) / Research Paper(s) in India or abroad. News item(s) excluded.
